**UNOPPOSED MOTION FOR EXTENSION OF TIME

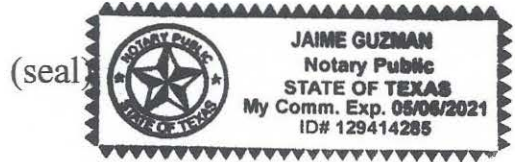
