For illustration, I prefer NOT to stop when light turns yellow or I want to drive 80 miles an hour because those are things I'm comfortable with—things I like to do and can hardly resist. So should we change the laws to accommodate my DESIRES? Of course not!

Likewise, people who choose the homosexual lifestyle should not demand we change the definition of marriage and our laws to accommodate their desires. There is no medical proof that homosexuality is a medical condition so that should not be considered when looking at changing our laws governing marriage.

I look forward to your responses and to your reconsidering this key case.
