UNOPPOSED MOTION TO EXTEND TIME TO FILE RESPONSE TO PETITION

TO THE HONORABLE SUPREME COURT OF TEXAS:

Pursuant to Rule 10.5(b) and Rule 53.7 of the Texas Rules of Appellate Procedure, Respondent files this motion and asks for a thirty (30) day extension of time by which to file his response to the petition. The Court recently requested a response to the petition and set the response date as July 10, 2017. Granting this motion would make the brief due on August 9, 2017.

This request is not made for the purpose of delay, but instead is necessary to allow Respondent's appellate counsel, Kurt Kuhn, adequate time to properly prepare the response.
